August / September 2009

Course Information

We are now able to confirm the details of our new session of British Sign Language (BSL) 1 courses that will be starting here at Deaf Action, in August and September 2009. These courses, which are accredited by the Scottish Qualifications Authority (SQA), are the continuation from the "SQA Introduction to British Sign Language" course, which all students should have completed before starting BSL1. In this booklet, you will find information on the course and details of how to apply to join it.

Courses - Course days and times are as follows:

Cost - The cost of the course is £350, this includes all course fees. If your employer is sponsoring you, please ensure that you complete and return the "Confirmation of Booking for Training" form (page 3), which must be signed by your employer. For all applications, excluding work sponsored places, a deposit of £50 must be received with the application in order to secure a place on the course, with the remaining balance due for payment at the 1st class.

Funding to attend may be available from the Glasgow Society for the Education of the Deaf and Dumb www.gsedd.org.uk and/or other sources.

ILA Scotland Funding - This course has been approved to participate in the ILA Scotland scheme. ILA Scotland is a Scottish Government scheme that can help pay for the cost of learning. It's for people who are 16 or over and living in Scotland. If your income is £22,000 a year or less, or you are on benefits, you can apply for a learner account from ILA Scotland that will give you up to £200 a year towards the cost of this course.

If you are planning to use your ILA Scotland funding to part pay for the course, you must have your account set up before the course starts. You can apply for the course without your account being set up, but you will not be able to join the course until it is. Cancellation - In the event that you have to withdraw from the course, the following cancellation charges will apply: we are unable to return the deposit if you withdraw from the class up to 7 days before the start date; the full fee is payable if you withdraw on, or after, the class start date.

To book a place - So, if you would like to start learning British Sign Language, please complete the application form (pages 2 & 3) and return it to Deaf Action, along with your deposit, as soon as possible. In the event that your application is unsuccessful, your deposit will be returned to you. We hope that you do decide to study with Deaf Action and look forward to welcoming you onto the course.
